- (2) Annual Fee, charged quarterly, at the first day of each period, with a minimum mentioned
- (3) Charged at the time of contract amendment
- (4) Charged at the time of cancellation
- (5) Up front fee, charged over the credit amount
- (6) The fee is calculated over the repayment amount
- (7) Up front fee, charged over de contracted limit
- (8) Charged over the contracted limit, at the renewal time
- (9) Charged over unused part of the overall credit limit and it is charged on interest payment dates. It has the same frequency that interest charges.
- (10) Importing Letters of Credit - Other associated expenditures:  
Correspondent 's expenditure - payable by customer, if agreed by the terms and conditions of the letter of credit, of if rejected by the beneficiary, according to the Uniform Customs and Practice for Documentary Credits (UCP 600).
- 1 - The fees are charged based on the maximum amount of credit plus the tolerance.
- 2 - The fee is calculated on the unused amount, i.e. outstanding balance.
- 3 - Monthly fee in term loans are applied on the amount of each usage, since the last day of the charge of the opening fees or the extension to maturity.
- (11) Export Letters of Credit - Other associated expenditures:  
Correspondent 's expenditure - payable by the customer, if agreed by the terms and conditions of the letter of credit, of if rejected by the beneficiary, according to the Uniform Customs and Practice for Documentary Credits (UCP 600).
